

General Instructions

If your business conducts restaurant sales, you must file this return even if no tax was collected during this filing period.

For detailed information regarding the restaurant tax, see Utah Code §59-12-603; Publication 25, *Sales and Use Tax General Information*; and Publication 55, *Sales Tax Information for Restaurants*.

Column Instructions

- Column 1 This is preprinted and requires no further entries by you.
- Column 2 This is preprinted and requires no further entries by you.
- Column 3 Enter the total charges for food and beverages, including alcohol, before sales tax for each county that imposes the tax in Utah. Add the amounts in column 3 and enter this amount on the Totals line beneath column 3.
- Column 4 This is preprinted and requires no further entries by you.

- Column 5 Multiply the entries in column 3 by the tax rate in column 4 for tax due. Add the amounts in column 5 and enter the total at the bottom of the page. Pay this amount.
