# ~ Important Notice ~ Utah Tobacco Tax Updates

## **Combined Tax Return & Filing Requirements**

In an effort to simplify the process of filing tobacco tax returns, effective July 1, 2013:

- Forms TC-552, TC-554, TC-555 and TC-562 will no longer be used for periods ending after June 30,
- <u>2013.</u> (The old forms will still be used for filing periods ending *on or before* June 30, 2013.)
- The tobacco tax return and the forms above will be combined into a single tax return with schedules for specific tobacco related business activities.
- You will now file quarterly using the new TC-553, Tobacco Products Tax Return.
  - Use the new tobacco tax return and schedules when you file your July-September quarterly period, which is due on or before October 31, 2013.
  - If you have filed monthly prior to July 2013, <u>you will change to quarterly.</u> For example, you will not file a separate monthly return or report for July, August or September. You will combine the July, August and September information and file quarterly using the new TC-553.
- File your tobacco tax return with schedules and pay your taxes online using our secure Taxpayer Access Point (TAP) at **taxexpress.utah.gov.** 
  - If you use the upload feature in TAP, a DRAFT template will be available beginning July 1, 2013.
  - You may go to TAP at **taxexpress.utah.gov** and choose Download Template under the For Businesses column.
  - Check regularly for updates to templates and instructions so you can program any system changes that may be needed to upload the new TC-553 and schedules.

## License Renewal Changes

- If you have multiple locations, we will set all licenses to renew on the same date.
- A one-time reduction in the length of time your licenses are valid may happen when the renewal dates for all licenses are set to the same date.
- As this change is made, we will send a combined renewal notice that will list the license(s) that need to be renewed and remind you of the due date for the renewal.
- When the time comes, <u>file your TC-38B License Renewal and pay \$20 for each license you renew</u>. File your renewal and pay online using TAP at **taxexpress.utah.gov**.

## **Legislative Updates**

Effective July 1, 2013, legislation puts in place **new requirements if you operate a Roll Your Own Machine**.

• You must review the <u>revised</u> Pub 65, *Tax Information for Retailers, Distributors and Stampers of Cigarettes and Tobacco Products* online at **tax.utah.gov** if you plan to operate a Roll Your Own Machine.

### **Please Note**

- You may be required to file other forms based on your tobacco related business activities. They will be available online, through your TAP account and may include:
  - TC-79, Cigarette Revenue Stamps Order Form
  - TC-557, Utah State Cigarette and Tobacco PACT Act Monthly Report
  - TC-564, Tobacco/Cigarette Tax Refund Request
