STATEMENT OF THE CASE

This matter came before the Utah State Tax Commission for an Initial Hearing pursuant to the provisions of the Utah Code Ann. §59-1-502.5 on November 9, 2006.

This matter is before the Utah State Tax Commission due to the request for revocation of Respondent's sales tax license, filed by Petitioner on August 28, 2006. The request arrived in the Appeals Section on September 12, 2006.

Petitioner requests revocation of sales tax license number #### pursuant to Utah Code

Ann. §59-12-106 on the grounds that Respondent has failed to comply with the Sales and Use

Tax Act.

As of November 9, 2006, Respondent owed \$\$\$\$ in taxes, penalties, and interest. Delinquencies began in the period of July 1997 to September 1997. Petitioner has attempted to

work with Respondent without success. Petitioner asserted Respondent has defaulted on several payment agreements. Respondent has not filed returns and has not submitted payments. Letters

and telephone messages have not produced a response. Calls made to two numbers during the

hearing did not produce contact. One number was disconnected. A message was left at the other.

Though staff sent notice of the hearing on September 20, 2006, to Respondent's last known address, Respondent did not participate in the hearing. Petitioner's evidence is uncontroverted.

DECISION AND ORDER

This account is substantially delinquent and has been delinquent since September of 1997, in violation of the provisions of the Sales and Use Tax Act. There are sufficient grounds to require revocation of the sales tax license.

Based on the foregoing, the Utah State Tax Commission hereby revokes Sales Tax License ##### for failure to comply with the provisions of the Utah Sales and Use Tax Act.

This decision does not limit a party's right to a Formal Hearing. However, this Order will become final unless any party to this case files a written request within thirty (30) days of the date of this decision to proceed to a Formal Hearing. The request for a Formal Hearing must be in writing and must include the names of the Petitioner and Respondent and the appeal number, as stated on this notice. The request shall be mailed to:
