II. Call to Order

Commission Chair Valentine called the meeting to order at 9:09 a.m.

III. Public Comment (individuals or groups wishing to address the Commissioners for up to three minutes on matters not related to a pending or reasonably imminent appeal to the Tax Commission)

IV. Consider approving the Commission Meeting Minutes of October 12, 2023 [action item]

MOTION: Commissioner Fresques moved to approve the Commission Meeting Minutes of October 12, 2023. The motion passed unanimously.

V. Consider Utah County Board of Equalization's, Summit County Board of Equalization and Salt Lake County Board of Equalization's requests for the extension of the time period for a county board of equalization to make a decision on an appeal *[action item]*

Commissioner Cragun: The Commission received a written request from the Utah County Board of Equalization, Summit County Board of Equalization and Salt Lake County Board of Equalization to extend the time period set by Utah Code Ann. §59-2-1004(7)(c) to make a decision on appeals received by the application deadline set by Utah Code Ann. §59-2-1004(3)(a). The Boards explained that they are unable to process within 60 days following the board's receipt of the taxpayer's application due to the large number of 2023 appeals filed. The Utah County Board asks the Commission to extend the time period for making a decision on appeals it received by September 15, 2023 to March 31, 2024. The Summit County Board asks the Commission to extend the time period for making a decision on appeals it received by September 15, 2023 to April 26, 2024. The Salt Lake County Board asks the Commission to extend the time period for making a decision on appeals it received by September 15, 2023 to April 26, 2024. The Salt Lake County Board asks the

Commission Chair Valentine took a roll call vote and the motion passed unanimously.

VI. Consider amending Administrative Rules. [action item]

- 1. R884-24P-33. 2024 Personal Property Valuation Guides and Schedules Pursuant to Utah Code Ann. Section 59-2-107.
- 2. R884-24P-20. Construction Work in Progress Pursuant to Utah Constitution Art. XIII, Section 2 and Utah Code Ann. Sections 59-2-201 and 59-2-301.

Commissioner Rockwell: The following rules were published in the Utah State Bulletin on Sept 15, 2023 and the public comment period ended on October 16, 2023. We did not receive any public comments on these rules.

 R884-24P-33. 2024 Personal Property Valuation Guides and Schedules Pursuant to Utah Code Ann. Section 59-2-107. Section 59-2-107 authorizes the State Tax Commission to make rules that define classes of items considered to be personal property and provide valuation percent good schedules to value personal property. County assessors must use the percent good schedules as contained in this rule. Any deviation that affects an entire class or type of personal property requires a written report documenting the schedule change to be submitted to the Tax Commission for approval prior to use. This proposed rule amendment modifies the percent good tables for the 2024 calendar year.

MOTION: Commissioner Rockwell moved to adopt the amendments to 884-24P-33. 2024 Personal Property Valuation Guides and Schedules Pursuant to Utah Code Ann. Section 59-2-107.

Commission Chair Valentine took a roll call vote and the motion passed unanimously.

 R884-24P-20. Construction Work in Progress Pursuant to Utah Constitution Art. XIII, Section 2 and Utah Code Ann. Sections 59-2-201 and 59-2-301. This proposed rule amendment defines "centrally assessed property" and "locally assessed property" consistent with Utah Code Ann. Sections 59-2-201 and 59-2-301, and clarifies that discount rates are not applicable to locally assessed property.

MOTION: Commissioner Rockwell moved to adopt the amendments to Rule 884-24P-20. Construction Work in Progress Pursuant to Utah Constitution Art. XIII, Section 2 and Utah Code Ann. Sections 59-2-201 and 59-2-301.

Commission Chair Valentine took a roll call vote and the motion passed unanimously.

VII. Commissioners' Reports

Commissioner Valentine spoke on an article published by the American Bar Association. He also recognized Commissioner Rockwell for becoming a fellow in the American College of Tax Council.

VIII. Executive Director Report
