- VI. Approve submission of proposed rule amendments to the Office of Administrative Rules for publication in the *Utah State Bulletin [action item]*
 - 1. R861-1A-43. Electronic Meetings Pursuant to Utah Code Ann. Section 52-4-207.
 - 2. R884-24P-19. Appraiser Designation Program Pursuant to Utah Code Ann. Sections 59-2-701and 59-2-702.

Commissioner Rockwell: The following proposed rule amendments are for the Commission to consider and submit for publication to the Office of Administrative Rules. The amended rules will be published in the Utah State Bulletin on October 15, 2024 and the mandatory public comment period will end on November 14, 2024.

 R861-1A-43. Electronic Meetings Pursuant to Utah Code Ann. Section 52-4-207. During the 2024 General Session, the Legislature passed House Bill 36, Open and Public Meetings Act, which authorized a public body to adopt rules governing public meetings where all members of the public body attend through an electronic connection. The amendments to this rule provide the ability for a public commission meeting to be held where all commissioners are attending remotely through electronic means. The amendments also specify how a quorum will be determined when all members are attending remotely.

MOTION *Commissioner Rockwell:* I move to submit the proposed amendments to R861-1A-43. Electronic Meetings Pursuant to Utah Code Ann. Section 52-4-207 to the Office of Administrative Rules for publication in the Utah State Bulletin.

Commissioner Valentine took a roll call vote and the motion passed unanimously

2. R884-24P-19. Appraiser Designation Program Pursuant to Utah Code Ann. Sections 59-2-701and 59-2-702. The amendments to this rule modify and clarify the education, training, designation, and continuing education requirements that must complied with for an individual within a county assessor's office or the Property Tax Division to be authorized to value real or personal property for purposes of ad valorem property taxation. The amendments also establish training, education, and designation requirements that must be an obtained by an individual elected to the office of county assessor. These requirements are consistent with Utah Code Section 59-2-702.5.

MOTION *Commissioner Rockwell:* I move to submit the proposed amendments to R884-24P-19. Appraiser Designation Program Pursuant to Utah Code Ann. Sections 59-2-701 and 59-2-702 to the Office of Administrative Rules for publication in the Utah State Bulletin.

Commissioner Valentine took a roll call vote and the motion passed unanimously

- VII. Consider amending Administrative Rules. [action item]
 - 1. R884-24P-16. Assessment of Interlocal Cooperation Act Project Entity Properties Pursuant to Utah Code Ann. Section 11-13-302.

Commissioner Rockwell: The following rules were published in the Utah State Bulletin on July 1, 2024 and the public comment period ended on July 31, 2024. We did not receive any public comments on these rules.

R884-24P-16. Assessment of Interlocal Cooperation Act Project Entity Properties Pursuant to Utah Code Ann. Section 11-13-302, modifies the rule consistent with the statutory changes made in 2022 General Session Senate Bill 20. The proposed amendments include: modifying the definition of "sold" for purposes of assessing the property of an interlocal cooperation project entity; and clarifying that the Utah fair market value of the property is not reduced by the value of any capacity, service, or

other benefit that is ultimately sold, resold, or laid off to an energy supplier whose tangible personal property is not exempt from the Utah ad valorem property tax under the Utah Constitution. The amendment to the rule also removes outdated language.

MOTION *Commissioner Rockwell:* I move to adopt the amendments to R884-24P-16. Assessment of Interlocal Cooperation Act Project Entity Properties Pursuant to Utah Code Ann. Section 11-13-302.

Commissioner Valentine took a roll call vote and the motion passed unanimously
