MOTION *Commissioner Cragun*: I move that we approve the settlement agreement for, *John D. Weist, Jr. v. Utah State Tax Commission and Board of Equalization of Salt Lake County,* Fourth Judicial District Court, Juab County, State of Utah, Tax Division, Case No. 240600012 and authorize counsel's signature on related documents.

- VI. Approve submission of proposed rule amendments to the Office of Administrative Rules for publication in the *Utah State Bulletin [action item]*
 - 1. R873-22M-20. Aircraft Registration Pursuant to Utah Code Ann. Sections 72-10-102, 72-10-109 through 72-10-112.
 - 2. R877-23V-5. Temporary Motor Vehicle Registration Permits and Extension Permits Issued by Dealers Pursuant to Utah Code Ann. Section 41-3-302.

Commissioner Rockwell: The following proposed rule amendments are for the Commission to consider and submit for publication to the Office of Administrative Rules. The amended rules will be published in the Utah State Bulletin on July 1, 2025 and the mandatory public comment period will end on July 31, 2025.

1. R873-22M-20. Aircraft Registration Pursuant to Utah Code Ann. Sections 72-10-102, 72-10-109 through 72-10-112. This proposed rule amendment repeals R873-22M-20, which provides for the registration of aircraft. The State Tax Commission used to register aircraft, but legislation was passed to transfer this responsibility to the Department of Transportation. Because the Tax Commission no longer registers aircraft, this rule is unnecessary and can be repealed.

MOTION *Commissioner Rockwell:* I move to submit the proposed amendments to R873-22M-20. Aircraft Registration Pursuant to Utah Code Ann. Sections 72-10-102, 72-10-109 through 72-10-112. to the Office of Administrative Rules for publication in the Utah State Bulletin.

Commission Chair Valentine took a roll call vote, and the motion passed unanimously

- 2. R877-23V-5. Temporary Motor Vehicle Registration Permits and Extension Permits Issued by Dealers Pursuant to Utah Code Ann. Section 41-3-302. This proposed rule amendment makes three changes to the motor vehicle permitting process.
 - (1) The previous procedure in rule for a dealer recording an extension permit approval number issued by the Motor Vehicle Enforcement Division (MVED) required unnecessary information that caused confusion. The changes in the draft clarify the way dealers record extension permits and require only the approval number to be recorded in the permit record and permit stub for the extension.
 - (2) During the COVID 19 pandemic, MVED temporarily allowed unlimited extensions to dealers requesting temporary permits due to the extraordinary delays in processing licenses. Upon resuming normal operation, MVED analyzed current data and determined that an increase in the percentage of temporary permits is warranted. Draft changes to the rule increase from 2% to 6% the amount of extensions a dealer may allow out of the total number of temporary permits issued to the dealer in the last three months.
 - (3) Currently rule allows only 10 days for a dealer to file the stub portion of a temporary permit with the division when the dealer sells a motor vehicle for registration in another state. This time period is very difficult to meet and is not enforceable. Proposed changes increase the filing period from 10 days to 45 days.

MOTION *Commissioner Rockwell:* I move to submit the proposed amendments to R877-23V-5. Temporary Motor Vehicle Registration Permits and Extension Permits Issued by Dealers Pursuant to Utah Code Ann. Section 41-3-302 to the Office of Administrative Rules for publication in the Utah State Bulletin.

Commission Chair Valentine took a roll call vote, and the motion passed unanimously

VII. Request for Rulemaking: Letter from Summit County

Commissioner Rockwell explanation of issue

MOTION *Commissioner Rockwell*: I move that the Commission decline to exercise rulemaking authority as requested in the letter from Summit County, and instead to honor the Commission's commitment to the Legislature to make rules consistent with R884-24P-66, and also to identify the issue raised in the Summit County letter when the Commission reports to the Revenue and Taxation Interim Committee on the rules proposed in implementing 2025 General Session HB 62.

Commission Chair Valentine took a roll call vote, and the motion passed unanimously
