# **Application to Rescind Dismantling Permit Instructions**

Read these instructions carefully.

# **Eligibility**

In order to rescind a dismantling permit and to re-title a vehicle, the vehicle must meet the following conditions:

- Prior to receiving a dismantling permit, the vehicle had a Utah certificate of title.
- 2. The vehicle has not been dismantled.

After you submit this form, an investigator for the Motor Vehicle Enforcement Division will physically inspect the vehicle and confirm it is the same vehicle for which the dismantling permit was issued.

#### **Step 1: Submit This Application**

Complete Sections 1 and 2 of this application and sign in Section 3. Mail the completed application and the \$50 application fee (check or money order payable to the *Utah State Tax Commission*) to the address shown below.

Or you may email this application to the email address shown below and we will contact you for payment.

# Step 2: Vehicle Inspection

Vehicle Compliance Services will complete Section 4 of this application and cash your \$50 application fee if the vehicle qualifies for an inspection. The Motor Vehicle Enforcement Division will then contact you to schedule a vehicle inspection.

If the vehicle does not qualify for an inspection, the \$50 fee will be returned to you.

After the inspection, the Motor Vehicle Enforcement Division will complete Section 5 of this application and return it to you.

### Step 3: Apply for Utah Title

To apply for a new Utah title, send the approved TC-829 application, Utah dismantling permit and form TC-656 (*Application for Utah Title*) to Vehicle Compliance Services. We will contact you for title and registration fee payment.
