**Instructions**

Either the *Combined Sales and Use* tax rate **or** the *Grocery Food* tax rate will apply to all taxable transactions. The rates under *Transient Room*, *Prepared Food* and *Short Term Leasing* include the applicable *Combined Sales and Use* tax rate.

Only one rate will apply to a single transaction. For example, the rate of 10.95% applies to the total taxable transient room charges in West Haven City.

In resort communities, the *Resort Exempt* rate is the *Combined Sales and Use* tax rate minus the resort community tax.
