Instructions

Either the Combined Sales and Use tax rate or the Grocery Food tax rate will apply to all taxable transactions. The rates under Transient Room, Prepared Food and Short Term Leasing include the applicable Combined Sales and Use tax rate.

Only one rate will apply to a single transaction. For example, the rate of 12.35% applies to the total taxable transient room charges in West Haven City.

These rate charts should not be used for sourcing sales from out-of-state sellers to locations in Utah. Out-of-state sellers should source their sales based on the ZIP +4 of the customer's address. For more information, see https://tax.utah.gov/sales/non-nexus

In resort communities, the Resort Exempt rate is the Combined Sales and Use tax rate minus the resort community tax.
